- To initiate new Post Graduate (PG) programmes in Civil Engineering, Mechanical Engineering, Electrical & Electronics Engineering, Electronics & Communication Engineering, Computer Science & Engineering, Mathematics, Physics, Chemistry, Humanities and Social Sciences, MBA, etc.
- To provide facilities for research in all Engineering departments, Basic and Applied Sciences and Humanities and Social Sciences leading to doctoral degree.

1.4 Education System

Education means overall development of an individual. An education system should attempt to provide the teaching and training of an individual in order to induce professional competence and ability, personality development, provide leadership to team work, concern for human values towards colleagues and subordinates, respect for superior, behave in a disciplined way and exercise the habits of punctuality, sincerity, devotion, hard work, integrity, honesty and concern for the people, society and nation.

The education system in National Institute of Technology Mizoram envisages achieving the above mentioned qualities by undertaking an integrated and balanced blend of curricular, co-curricular and extra-curricular activities among students, teachers and supporting staff and by creating congenial and close relations among all.

National Institute of Technology Mizoram, at present, offers 4 (four) UG courses, viz., Electrical & Electronics Engineering, Electronics & Communication Engineering, Computer Science & Engineering and Mechanical Engineering. The Institute follows a credit based system for academic evaluation. It offers industrial training and project as a part of the education system.

1.5 New Initiatives

The Institute started functioning in the Mizoram campus from the academic session of the year 2011. Some of the initiatives taken since then are as follows:

i) New Academic Rule and Regulation:

A new Academic Rule and Regulation was drafted in consultation with the Director and faculty members of the Institute with the help of Rules and Regulations of other institutes of repute. This new Rule and Regulation after the approval of the Senate and the Board of Governors (BOG) of the Institute came into force from the new academic session of the year 2012.

ii) New Academic Calendar:

An academic calendar has been drafted in line with the weather conditions of the state of Mizoram and henceforth came into force from the new academic session of the year 2012.

2.1 Historical Background

National Institute of Technology Mizoram is one of the 10 (ten) new NITs set up by the Government of India in 2009 to meet the demand for technical and scientific education and to ensure every state in India having its own NIT. NIT Mizoram was established vide Ministry of Human Resource Development, Govt. of India order no. F-23-13/2009/TS-III dated 30th October, 2009. The Institute started functioning from the camp Nagpur under the mentorship of VNIT Nagpur w.e.f. July 2010 with a total of 63 students in three branches of engineering, viz., Electrical & Electronics Engineering, Electronics & Communication Engineering and Computer Science & Engineering.

NIT Mizoram started functioning from its Mizoram campus from July 2011. VNIT Nagpur was the mentor institute till 1st December, 2011.

The Institute is now governed by the National Institute of Technology (Amendment) Act, 2012, No. 28 of 2012 (An Act to Amend the National Institute of Technology, 2007) and henceforth designated as an Institute of National Importance.

2.2 Location

NIT Mizoram is, at present, situated at Chaitlang, Aizawl. Aizawl is the capital city of Mizoram. Mizoram is situated at 23° 30" N latitude and 20° 52" E longitude. Mizoram has a mild and pleasant climate. The temperature varies from a minimum 7°C in the winter season to 29°C in the summer season. The area has an approximate annual rainfall of 254 cm (100 in) per annum.

2.3 Campus

The Institute is, at present, functioning from temporarily hired buildings at Chaitlang, Aizawl.

The permanent campus of the Institute is coming up at Lengpui, Aizawl, near airport. At present, 4 (four) buildings are on rent at Chaitlang and its vicinity for accommodating 1 (one) Administrative Block and 3 (three) Academic blocks for conducting classes and laboratories. Other 4 (four) buildings are on rent for 3 (three) boys hostel and 1 (one) girls hostel.

2.4 Administration

The Institute is being administered by the Director of the Institute with direct supervision of the Board of Governors (BOG) headed by Chairman. The Director of the Institute is ex-officio Member of the BOG.

2.5 Academic Programmes

The Institute, at present, offers UG programmes leading to the degree of Bachelor of Technology (B. Tech.) in Electrical and Electronics Engineering, Electronics and Communication Engineering, Computer Science & Engineering and Mechanical Engineering.

2.6 Courses Offered

Currently the Institute offers courses in 4 (four) branches leading to B. Tech. Degree of 4 – years duration, viz.,

- Electrical & Electronics Engineering (EEE)
- Electronics & Communication Engineering (ECE)
- Computer Science & Engineering (CSE)
- Mechanical Engineering (ME)

2.7 Admission Procedure

The admission to 1st year B. Tech. course is made through the Joint Entrance Examination (JEE) Main conducted by Central Seat Allocation Board (CSAB) and as per the guidelines of the Ministry of Human Resource Development, Govt. of India. The Institute acts as one of the Counselling and Help centres.


2.8 Students

The intake of the Institute is, at present, 30 seats per branch. Out of the total intake, 50 percent of the seats are reserved for the state and the rest 50 percent is open to students from all parts of the country. Reservation of seats for Scheduled Castes, Scheduled Tribes and Physically Handicapped candidates are as per Government of India norms.

2.9 Examination and Evaluation

Since the beginning the Institute has been conducting examinations for the UG courses. The Examination Section centrally conducts Mid-semester and End-semester examination in respect of theory components of the subjects unless otherwise permitted. The results are declared in terms of Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA) on 10 (ten) point scale. As per national standard, results are declared after one week of the completion of the examination.

There is a continuous assessment of the students' performance throughout the semester and grades are awarded by the concerned teacher. In case of theoretical subjects, the evaluation is based on class assessment (attendance, class tests, assignments, quizzes, etc.), mid-semester examination and end-semester examination. The respective weightage for these subcomponents are as below:



In case of sessional subjects (Laboratory, Design, Practical, Workshop, etc.), the evaluation is based on the basis of attendance, assessment of tasks assigned and the end-semester test/viva.

2.10 Games and Sports

The students of the Institute actively participate in Games and Sports, Cultural and Technical Fests, Quizzes, Debates and other co-curricular and extra-curricular activities. Sport is a compulsory subject for all the first year students.

10.1 Library

The Institute has a central library which approximately consists of 6500 books. Out of this about 6000 books belong to general textbooks for use in regular classes and about 500 books are for reference section. The Institute has further sent orders for acquisition of about 2000 books to meet the requirements of the coming semesters. Apart from this, the Library also has about 406 titles of E-books belonging to various departments of the Institute. Besides a good number of journals, reports, magazines and national and regional newspapers are stacked in the Institute Library.

10.2 Workshops

The Institute has one central workshop with good number of machines and instruments. The various shops available are Carpentry, Fitting, Welding and Machine shop.

10.3 Computer Centre

The Computer Center is having 2 computer laboratories, one as Network laboratory and another as Programming laboratory, in the Department of Computer Science and Engineering consisting of 60 nos. of computers. These Laboratories are used by the students as well as faculty members of the Institute. The Institute has 100 mbps internet connectivity (24X7) under National Knowledge Network (NKN), Govt. of India, connected through redundant fiber cables which will be upgraded to 1Gbps (1000Mbps) very soon. Apart from this, the institute is also having a 2Mbps leased line internet connection from BSNL as redundant connectivity. As a whole the institute is connected and properly networked via cisco router and switches. The students and other faculty members used to visit computer center for their computing work other than regular Lab classes. To enhance the facilities of computer center new hardware and software are procured on regular basis.

Each department in the Institute has various laboratories with well equipped instruments and machines.



Separate Audit Report of the C & AG of India on the Accounts of the National Institute of Technology, Mizoram, Aizawl for the year ended 31 March 2014

1. We have audited the attached Balance Sheet of National Institute of Technology, Mizoram as at 31 March 2014, Income & Expenditure Accounts and Receipt & Payment Accounts for the year ended on that date under Section 20(1) of the Comptroller & Auditor General of India (Duties, Powers and Conditions of Service) Act, 1971 read with Section 22(2) of NIT Act, 2007. Our responsibility is to express an opinion on these financial statements based on our audit.
2. The Separate Audit Report contains the comments of the Comptroller & Auditor General (C&AG) of India on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms etc. Audit observations on financial transactions with regard to compliance with the law, Rules and Regulations (Propriety & Regularity) and efficiency-cum performance aspects, etc. if any, are reported through Inspection Reports/C AG's Audit Report separately.
3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require us to plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examination, on a test basis, evidences supporting the amounts and disclosures as depicted in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of the financial statements. We believe that our audit provides a reasonable basis for our opinion.
4. Based on our audit we report that:
 - I. We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit.
 - II. The Balance Sheet, Income & Expenditure Account and Receipt & Payments Account dealt with by this report have been drawn up in the format prescribed by the Ministry of Finance.
 - III. In our opinion, proper books of accounts and other relevant records have been maintained by the National Institute of Technology (NIT), Mizoram, Aizawl as required under Rules in so far as it appears from our examination of such books.
 - IV. We further report that:

A. Balance sheet

1. Current liabilities & provisions (Schedule -7)

NPS (Employees contribution) : ₹ 16,42,196

₹ 25,95,662

A liability of ₹ 25.96 lakh was shown as other current liabilities on New Pension Scheme (NPS) under Schedule -7 of the Annual Accounts for the year 2013-14. However, the detailed statements showing employee wise balances in respect of NPS as of 31 March 2014, the actual liability works out to ₹ 30,46,626 (2011-12: ₹ 6,51,160 + 2012-13: ₹ 11,91,703 + 2013-14: ₹ 12,03,763).

Further, the NPS so deducted has not been remitted upto 31 March 2015.

This has resulted in understatement of Current Liabilities and Provisions and expenditure by ₹ 4.51 lakh each.

B. Income and Expenditure Account

1. Income (Schedule -17)

Interest earned : ₹ 96,27,980

An interest of ₹ 96,27,980 earned during the year was exhibited under Schedule -17 of the Annual Accounts for the year 2013-14. However, the scrutiny of records revealed that the Institute earned

Thus, understatement of income of ₹ 4,20,791 (₹ 1,00,48,771 - ₹ 96,27,980) resulted in understatement of Excess of Income over Expenditure by ₹ 4,20,791.

B. Grants-in-Aid

Out of total Plan Grants provided during the year 2013-14 of ₹ 12 crore for creation of Assets (all Non-Recurring and Plan Fund), the Institute spent a sum of ₹ 5.94 crore constituting 49.50 per cent only leaving a balance of ₹ 6.06 crore as on 1 April 2014.

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipt & Payment Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of information received and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts subject to the significant matters stated above and other matters mentioned in the Annexure to this Audit report give a true and fair view in conformity with accounting principles generally accepted in India
- vii. In so far as it relates to the Balance Sheet of the state of affairs of the NIT, Mizoram as at 31 March, 2014; and
- viii. In so far as it relates to Income & Expenditure Account of the surplus for the year ended on that date.

SCHEDULE 24 - SIGNIFICANT ACCOUNTING POLICIES

1. BASIC OF ACCOUNTS PREPARATION:

The Accounts are prepared under the Historical Cost Convention unless otherwise stated and generally prepared on the basis of Accrual Method of Accounting.

2. REVENUE RECOGNITION :

Fees from Students, Sale of Admission Forms etc. are accounted for on accrual basis. Income from Land, Building and other properties and Interest on Fixed Deposits are accounted for on accrual basis.

3. FIXED ASSETS AND DEPRECIATION:

- 3.1 Fixed Assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning.
- 3.2 Gifted/Donated assets are valued at the declared value wherever available; if not available the value is estimated based on the present market value and the physical condition of the assets. They are set-up by credit to Capital Fund and merged with the fixed assets. Depreciation is charged at the rates applicable to the respective assets.
- 3.3 Books received as gifts, are valued at selling prices printed on the books. Where they are not printed, the value is based on assessment.
- 3.4 Expenditure on acquisition of software is separated from Computer & Peripherals, as part from being intangible assets, the rate of obsolescence in respect of these is very high. Depreciation is provided in respect of software at a higher rate of 40% as against depreciation of 20% provided in respect of Computer & Peripheral.
- 3.5 Fixed Assets are valued at cost less accumulated Depreciation. Depreciation on Fixed Assets on straight line method, at the following rates.

- 3.6 Depreciation is provided from the date of acquisition /Put to use on additions during the year, irrespective of the period of usage up till FY 2012-13, however from FY 2013-14, the policy is changed by charging the depreciation on pro-rata basis on daily basis.

- 3.7 Where an asset is fully depreciated, it will be carried at a residual value Re.1 in the Balance Sheet and will not be further depreciated.

- 3.8 Assets created out of Earmarked Funds and Funds of sponsored projects, where the ownership of such assets vests in the NIT, Mizoram are setup by credit Capital Fund and merged with the Fixed Assets of the NIT, Mizoram. Depreciation is charged at the rate applicable to the respective assets.

STOCKS:-

Expenditure on purchase of Chemicals, Glassware, publication and other store is accounted as revenue expenditure and charged off in the year of purchase.

RETIREMENT BENEFITS:-

The policy for the retirement benefits has so far not been designed. However, the contribution to the retirement benefits in the form of Leave Encashment and Pension Fund is accounted for as expense during the period it is becoming due.

INVESTMENTS:-

All the investments are valued at cost or market value whichever is lower.

GOVERNMENT GRANTS:-

- 7.1 Government Grants are accounted on realization basis. However, as an exception where a sanction for the release of grant pertaining to the financial year is received before 31st March and the grant is actually received in the next financial year, the grant covered by such sanction is accounted on accrual basis and equal amount is shown as recoverable from the grantor.

- 9.1 To the extent utilized towards capital expenditure, government grants are transferred to the Capital Fund.
- 9.2 Government grants for meeting Revenue Expenditure are treated, to the extent utilized, as income of the year in which they are realized.
- 9.3 Non-utilized grants (including advances paid out of such grants) are carried forward and exhibited as a liability in the Balance Sheet.
